Whereas, the First Party has various contracts with Refineries, Petrochemical Plants & other Plants and wants to award some of its work to local subcontractor Experience in the field of industrial maintenance and the Second Party has agreed to provide these services.

Both parties have agreed on the following:

**1-Scope of Work**

Except as otherwise provided in the contract, the Second Party shall provide/supply scope of work services, equipment's, materials, and skilled workers required to execute/perform the job as agreed in accordance with terms and conditions of the contract.

**2-Contract Period**

This Contract starting from 23/10/2024 ending by 22/10/2026 unless terminated or extended in accordance with terms and conditions of this contract, unless otherwise the one-year period is considered.

The first party reserves the right to extend the term of the contract in accordance with the provisions and the existing original or supporting terms unless the full year option is exercised.

**3-Contract Price**

The First party shall pay the Second Party the rates as specified in purchase order.

4-The First Party will be responsible to arrange entry stickers and cards for the Second Party to perform work at site.

5-The Second Party is responsible to provide all required documents for this purpose to the First Party and Second Party guarantees the authenticity, activity, validity, and legality of such documents submitted to the First Party.

6-The Second Party is responsible for paying salaries and wages to their employees working on the project and by no means should it be delayed.

7-The Second Party is responsible for the sponsorship of all staff working on the project and insurance coverage for them (including third party liability insurance, GOSI, accident coverage, etc.).

8-The Second Party shall provide monthly bills supported by documents and execution timecards which are supported by project supervisor authorized by the First Party.

9-The First Party shall pay bills to The Second Party which is approved from project supervisor within 60 days of bills receipt.
